Protecting Our Pensions in 2022

The Arizona Retirement Security Coalition (ARSC) is comprised of nine core partners, including All Arizona School Retirees Association (AASRA), Arizona Education Association (AEA), AEA-Retired, and other labor and community organizations. During the 2022 legislative session, the Coalition and our lobbyist, Daniella Smith, successfully defeated two bills that threatened the stability and fiscal health of the Arizona State Retirement System (ASRS).

SB1145 ABOR; OPTIONAL RETIREMENT PROGRAMS - sponsored by Senator Warren Petersen.

This bill would have allowed the three public universities to opt out of the ASRS by offering their optional retirement program (ORP) to all new employees in lieu of the ASRS plan. The universities claimed this legislation was intended to provide new employees more choices for retirement planning, but that was misleading. The bill's purpose was to save the universities money by shifting most of the investment risks and fees from the employers to their new, lower income employees. If passed, the ASRS estimated that this legislation could cost the system approximately \$675 million dollars over the next 20 years.

As soon as the bill was assigned to the Senate Finance committee, Coalition partners contacted stakeholders and other legislators, asking them to oppose it. We asked our partners to encourage their members to contact Sen. David Livingston, chair of the committee, and request that he not schedule this bill for a hearing.

With help from the National Public Pension Coalition (NPPC), we also sent digital messages to stakeholder groups, Coalition partner members, and other interested parties asking them to contact Sen. Livingston and request that he not hear the bill Our efforts paid off because he did not schedule the bill for a hearing, thus killing it. HB2637 DIVESTMENT; K-12; ABORTION; EXPLICIT MATERIAL - sponsored by Rep. Jake Hoffman.

This bill would have required the State Board of Investment (SBOI), the Arizona State Retirement System (ASRS) Board and the Public Safety Personnel Retirement System (PSPRS) Board to adopt a policy for identifying and divesting from companies that donate to or invest in organizations that promote, facilitate or advocate for abortions for minors, and companies that donate to or invest in organizations that promote, facilitate or advocate for the inclusion of, or the referral of students to "sexually explicit materials" in K-12 education.

Problems with this bill:

- The definitions of sexually explicit materials and advocacy for abortion were extremely broad and vague and would have forced the ASRS, PSPRS and SBOI to divest from major companies such as Amazon.
- responsibility and fiduciary duty is to maximize investment returns of the \$50 billion dollar trust fund under their control. This is achieved by making long-term investment decisions that generate the highest returns. If ASRS investment managers must constantly restructure, reevaluate and rebalance investment portfolios based on political or social agendas, investment fees would most likely increase, rates of return would decrease, and contribution rates would go up.
- The definition of "sexually explicit materials" was so broad it would have required divestment from profitable companies that provide materials found in current, school board approved sex education programs across the country. It could have forced the ASRS to divest from companies that publish or provide books and materials found in high school English classes or magazines currently in school libraries, such as *The National Geographic*.

➤ Between the likelihood of contribution rates increasing, investment returns decreasing and the administrative nightmare this would create, HB2637 was a recipe for disaster!

We did a **lot of work** on this bill, both openly and behind the scenes, because other stakeholders chose not to take a position due to the controversial political issues involved. Fortunately, we were able to get the pension systems removed from the legislation. Ultimately, it was not heard in the Senate. Then a strike-everything amendment was added, effectively killing the original bill.

From where we began, with no other stakeholder groups willing to take a stand against the bill, to successfully stopping it, was a HUGE victory!



This is a short summary of the critically important work that the Arizona Retirement Security Coalition has been

doing for the last five years on behalf of public employees, our defined benefit pension system and public sector retirees in Arizona.

Stop Universal Vouchers!

A Short Background

On June 24th the Arizona Legislature passed House Bill 2853, sponsored by Representative Ben Toma (R-LD22). This legislation removed all qualifiers and limitations for receiving a private school voucher of almost \$7,000 dollars per year. Every school age child in Arizona (more than 1.1 million) would be eligible to receive this money!

The bill passed along party lines; it received just enough YES votes in each chamber to pass. The bill also appropriated \$2.2 million dollars from the General Fund to pay for the largest private school voucher expansion in the country. On July 7th, Governor Ducey signed it into law.

The grassroots pro public education group Save Our School Arizona (SOS AZ) immediately began circulating petitions to put a referendum on the November 2024 ballot which would, if approved, strike down the new law. If SOS AZ is able to gather at least 118,823 valid signatures before September 24, 2022, the law will be put on hold until the 2024 general election.

In 2017 this same group, then newly formed, did the seemingly impossible. They gathered over 100,000 signatures during the sweltering summer months and put Proposition 305 on the 2018 general election ballot. Arizona voters overwhelmingly rejected that voucher expansion effort, 65% to 35%. We are confident they will do so again!

Where We Are Today

One of AASRA's goals in our Constitution is to support public education. This is also reflected in our Legislative Priorities as adopted by the Board of Directors each year.

Acting on this is imperative, Joe Carter, AASRA Legislative Liaison and Terry Bagwell, AASRA Communications Chair, supported SOS AZ's efforts by publishing progress reports and updates on the petition drive throughout the summer months. We invited speakers from this group to address our members and gather signatures at unit meetings held in September. We encouraged our members to become involved with the petition drive and support SOS AZ through their donations



On September 26th, various local outlets reported that the STOP UNIVERSAL VOUCHERS! petition drive had fallen short of the 118,823 signatures needed to place the measure on the ballot.

This was very disheartening news. We do not want others to privatize the most accessible and inclusive public education system in the world today!

As I hope you know, the All Arizona School Retirees Association (AASRA) might not be here except for the efforts of Dr. Ethel Percy Andrus. Dr. Andrus, the retired first woman high school principal in California, helped southern Arizona retired educators in 1950 to establish a group that advocated for increasing pensions for retired teachers. Within a few years, once again with help from Dr. Andrus, the statewide organization that is today called AASRA was founded.

Dr. Andrus also founded the National Retired Teachers Association (NRTA) and the American Association of Retired Persons (AARP). AASRA's lifelong affiliation with both NRTA and AARP is natural and mutually beneficial. That affiliation continues today in various forms, but the most obvious is that AASRA has a position on the Advocacy Steering Board of AARP Arizona.

I have had the good fortune to serve in the position of AASRA Liaison to AARP Arizona for the last two years. In that role, I have input to AARP Arizona on their advocacy for the aging in our state and country. Also, I have the opportunity to keep other Advocacy Board members apprised of issues affecting retired school employees. In addition, I have the duty to keep AASRA members informed about which issues AARP & AARP Arizona are currently advocating.

During the last two years, AARP's primary focus has been on reducing medical costs for seniors, specifically those enrolled in Medicare. Most of that advocacy has been aimed at the US Congress. AARP Arizona's Executive Director, Dana Kennedy, has testified before Congress on behalf of the many that are adversely affected by high medical and prescription costs. As I'm sure you know, with the passage of the Inflation Reduction Act some of those goals have been accomplished.

Other issues that AARP Arizona has worked on include long-term care and facility access for family members and public health officials, housing for the unhoused, public transportation availability for the aging, utility costs, COVID-19 as a public health issue, and livable wages.

I will keep the AASRA Board informed of AARP foci at each meeting (and maybe in between, as well) and I will be sure to keep you informed with each newsletter. The total fund is funded at \$50,221,000,000. It is 71.5% funded. Through the years you have seen higher and lower funded status. Many of the figures change as determined by a different set of standards. The ASRS is one of the top state retirement funds in the nation. We are fortunate to have such a great retirement system.

ASRS Health information:

Open enrollment is the whole month of November. Enrollment Guide books are being mailed to retirees in mid-October.

The non-Medicare medical and dental plans will have the same premiums and benefit structure as this year.

The medical benefit structure remains unchanged for both Medicare Advantage plans and monthly premiums will increase in 2023 due to a year over year reduction in the Retrospective Rate Agreement funds available for premium reduction.

The fitness program within the Medical plans will transition from SilverSneakers® to the UHC Fitness Program. The new UHC Fitness program features an expanded network of fitness centers and fitness options.
